NOTICE OF APPLICATION FOR AN AMENDMENT OF CERTIFICATE
AND EXTENSION OF SERVICE AREA

November 29, 2000

AQUASOURCE UTILITY, INC., 200 Corporate Center Drive, Suite 300, Coraopolis, PA 15108, pursuant to Section 367.045, Florida Statutes, hereby notices its intent to apply to the Florida Public Service Commission for an extension of its service area to provide water service to the property located in Highlands County, Florida, described below:

The southeast 1/4 of the southeast 1/4 of Section 28, the southwest 1/4 of Section 27, the east 1/2 of Section 31, all of Sections 32 and 33, the northwest 1/4 and the northwest 1/4 of the southwest 1/4 of Section 34, all in Township 35 South, Range 29 East; also including lots 16 through 25 of Sebring Lake Acres Unit 1 in Section 4, Township 35 South, Range 29 East; less the westerly 305' of the northwest 1/4 of the southwest 1/4 of Section 27, Township 35 South, Range 29 East.
