Enclosed are two confidential documents which are being filed by Sprint Spectrum L.P. d/b/a Sprint PCS ("Sprint PCS") as requested by Staff.

The first document is a paper copy of Sprint PCS' revised cost study. This revised cost study contains the same, but updated, information and material for which the Commission, on August 30, 2000, issued its Order No. PSC-00-1564-CFO-TP, granting confidential treatment of Sprint PCS' cost study (Document No. 07649-00). On November 16, 2000, Sprint PCS filed a CD-ROM version of this updated cost study requesting continued confidential treatment. Staff has requested a paper copy. A highlighted copy of the cost study, as well as two redacted copies are being furnished in compliance with the Commission Rules. Please provide confidential treatment of this document in the same manner and to the same extent granted by Order No. PSC-00-1564-CFO-TP.

The second document is two pages, pages 31 and 32, from Sprint PCS' response to BellSouth's 1<sup>st</sup> Set of Interrogatories, No. 79. Sprint PCS, on October 11, 2000, requested confidential treatment of several documents provided in response to BellSouth's discovery, including the entire document "Nationwide PCS Network CDMA RF Design Specification (Rev. 9)," consisting of 53 pages. Staff has advised that these two pages were inadvertently left out of the copy accessed by Staff. These two pages should also be afforded confidential treatment pending the Commission's ruling on Sprint PCS' pending request for confidential classification. A highlighted copy, together with two redacted copies, are being furnished in compliance with the Commission Rules.




