



During the calendar years 1997, 1998, 1999, and 2000, Clay Electric Cooperative, Inc. ("Clay Electric") did not transfer any customers to the City of Alachua. The last transfer occurred in 1996 with the transfer of forty-seven (47) accounts from Clay Electric to the City of Alachua. This leaves a balance of ninety-four (94) accounts yet to be transferred in accordance with the Change In Use provisions of Sections 1.12 and 2.3 of the Agreement.


