

APPLICATION

CTSI, Inc. (“CTSI”), by its undersigned counsel and pursuant to Florida Public Service Commission (“Commission”) Rule 25-24.474, hereby submits the following application for an order canceling its Certificate to provide interexchange telecommunications service in the State of Florida, and for leave to withdraw its associated tariff. CTSI submits the following information in support of this Application:

1. CTSI is a Pennsylvania corporation authorized to conduct business in the State of Florida.
2. By Commission Order No. PSC-00-1294-CO-TI in Docket No. 991704-TI, issued on July 18, 2000, CTSI was granted a Certificate to provide interexchange telecommunications service throughout the State of Florida. Due to a change in its business plan, CTSI no longer requires its Certificate. CTSI has no customers in Florida, nor has CTSI ever provided services in Florida.
3. Pursuant to Commission Rule 25-24.474(a), CTSI intends to pay its Regulatory

Assessment Fee for calendar year 2000 not later than January 30, 2001.

5. As noted above, CTSI has no telecommunications customers in Florida. Therefore, CTSI will not provide notice of the discontinuance of service to customers, nor settle customer deposits and final bills.

WHEREFORE, CTSI, Inc. respectfully requests that the Commission approve this Application to permit the cancellation of CTSI's Certificate and the withdrawal and cancellation of CTSI's tariff.
