Agreed Motion for Extension of Time

ITC^DeltaCom Communications, Inc., d/b/a ITC^DeltaCom ("ITC^DeltaCom") and BellSouth Telecommunications, Inc., ("BellSouth") by their undersigned counsel, submit this Agreed Motion for Extension of Time ("Motion") and in support thereof state as follows:

1. On November 22, 2000, the Commission issued its Final Order on Arbitration, Order No. PSC-00-2233-FOF-TP, in this proceeding. Therein, the Commission ordered the parties to submit a signed interconnection agreement compliant with its decisions within twenty days of the issuance of the Final Order.

2. On December 6, 2000, BellSouth's office contacted ITC^DeltaCom's counsel and the Parties agreed that because the interconnection agreement has not been completed and due to the upcoming holidays, it would be appropriate to request from the Commission an extension of the time for filing a new interconnection agreement until 30 days from December 12, 2000.


3. ITC^DeltaCom is authorized to represent that BellSouth joins in and consents to this motion. Thus, the parties hereby request that the Commission grant an extension of time of 30 days from December 12, 2000 for filing the interconnection agreement.


