



**BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF
INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Specified Confidential Classification.

1. On December 12, 2000, BellSouth Telecommunications, Inc. filed its responses to Staff's First Set of Interrogatories and First Request for Production of Documents. BellSouth's response to Staff's Interrogatory No. 6 contains confidential business information that is considered proprietary to Sprint Spectrum L.P. d/b/a (Sprint PCS). The information provided was obtained from cost studies that Sprint PCS provided as an attachment to their Petition for Arbitration filed on June 23, 2000. BellSouth has signed a Protective Agreement with Sprint PCS. Because Sprint PCS claims that certain portions of its cost study contain proprietary and confidential business information, BellSouth has treated a portion of its response as confidential.


