Order No. PSC-00-1743-PAA-TC, issued on September 26, 2000, imposed a \$500 fine or cancelled the company's certificate. The Commission received the company's payment of the \$500 fine on October 17, 2000. In addition, on October 31, 2000, the Commission received payment for the 1999 and 2000 regulatory assessment fees, including penalty and interest charges, along with a letter requesting voluntary cancellation.

I revised the CASR believing that this needed to go back to Agenda to vote on the voluntary cancellation. However, Legal staff advised that this docket needs to be closed and the certificate not cancelled since the company basically complied with the Order. The company's request for voluntary cancellation is being forwarded to the Division of Regulatory Oversight for handling. A new docket will then be opened to address the voluntary cancellation with an effective date of October 31, 2000. Accordingly, please close this docket and DO NOT cancel the certificate. In addition, the events currently scheduled in Docket No. 000909-TC should be deleted.
