**MOTION TO ACCEPT FILING OF REBUTTAL TESTIMONY**


1. The procedural schedule in this case called for rebuttal testimony to be filed on or before December 13, 2000.
2. Due to unavoidable delays reproducing its rebuttal testimony, Sprint PCS’ rebuttal testimony did not arrive by hand delivery at the Division of Records and Reporting until a few minutes after 5:00 p.m. on December 13<sup>th</sup>. Since the Division of Records and Reporting was closed, the rebuttal testimony was filed with the Division of Records and Reporting at 8:31 a.m. on December 14, 2000.
3. Sprint PCS’ rebuttal testimony was served on BellSouth by hand delivery and overnight express on December 13, 2000.
4. Accepting Sprint PCS’ rebuttal testimony for filing one day late will not prejudice any of the parties in this case. The undersigned had discussed this Motion with counsel for BellSouth and is authorized to represent that BellSouth does not object to this Motion.

WHEREFORE, Sprint PCS respectfully requests that the Commission accept the rebuttal testimony of Bridger M. Mitchell, Michael R. Hunsucker, Randy G. Farrar and Anthony Sabatino one day late.


