CITY GAS COMPANY OF FLORIDA'S REQUEST FOR CONFIDENTIAL CLASSIFICATION FOR RESPONSE TO REQUEST #28 OF STAFF'S FOURTH REQUEST FOR PRODUCTION OF DOCUMENTS

City Gas Company of Florida, a division of NUI Corporation ("NUI/City Gas") pursuant to Section 366.093, Florida Statutes and Rule 25-22.006(3)(a)2 and (4), Florida Administrative Code, submits this Request for Confidential Classification of the documents described below which were provided to the Commission staff in its response to Request No. 28 of Staff's Fourth Request for Production of Documents. In support of this request for Confidential Classification, NUI/City Gas states as follows:

- 1. In connection with Staff's Fourth Request for Production of Documents, NUI/City provided documents to the staff containing information that is "proprietary business information" under Section 366/093(3), Florida Statutes. All items for which the company is requesting confidentiality have been held as confidential and have not been released to the public.
- 2. The confidential information at issue provided to the Commission staff is found at pages 1 through 4 of the Company's response to Request No. 28 of the Staff's Fourth Request for Production of Documents. A detailed description of the information for which the Company seeks confidentiality, including page numbers, line numbers or fields, and rationale, is attached hereto as Exhibit A.

- 3. On November 28, 2000, the Company filed with this Commission its Notice of Intent to Seek Confidential Classification of these documents. As stated in the Notice of Intent, this formal Request for Confidential Classification is now being filed within the time period specified in Rule 25-22.006(3)(a), Florida Administrative Code.
- 4. NUI/City Gas requests that the above-described information be classified as "proprietary business information" within the meaning of Section 366.093(3), Florida Statutes. The information and documents at issue are intended to be, and are, treated by NUI/City Gas as proprietary and confidential. Exhibit A contains a detailed explanation of the information and documents for which confidential treatment is requested, and justification for the requested confidential treatment of the highlighted portions of the enclosed documents.
- 5. A version of above described documents on which the information for which confidentiality is requested has been highlighted is being submitted to the Division of Records and Reporting under a separate cover. A redacted version of the documents on which the information asserted to be confidential had been blocked out is attached hereto as Exhibit B.
- 6. NUI/City Gas requests that the information for which it seeks confidential classification remain confidential for a period of at least 18 months as provided in Section 366.093(4), Florida Statutes.

WHEREFORE, for the foregoing reasons, NUI/City Gas respectfully requests that its Request for Confidential Classification be granted.




