- **05/19/94** - This company obtained Pay Telephone Certificate No. 3756.
- **12/08/99** - The Division of Administration mailed the regulatory assessment fee (RAF) notice. Payment was due January 31, 2000.
- **02/29/00** - The Division of Administration mailed a delinquent notice to the company.
- **03/30/00** - The Commission received a letter from the company, which responded to the Show Cause Order in Docket No. 000034-TI. The company requested cancellation of its interexchange telecommunications and pay telephone certificates.

- **07/11/00** - Staff wrote the company and advised that before we could recommend a voluntary cancellation, it needed to pay the past due penalty and interest charges for 1995 and 1999, and provide a date certain the 2000 fee would be paid.

The Commission is vested with jurisdiction over this matter pursuant to Sections 364.336 and 364.285, Florida Statutes. Accordingly, staff believes the following recommendations are appropriate.

ISSUE 2: Should this docket be closed?

RECOMMENDATION: Yes. The Order issued from this recommendation will become final upon issuance of a consummating order, unless a person whose substantial interests are affected by the Commission's decision files a protest within 21 days of issuance of the proposed agency action order. The docket should then be closed upon receipt of the fees or cancellation of the certificate. (K. Peña; B. Keating)

STAFF ANALYSIS: Whether staff's recommendation on Issue 1 is approved or denied, the result will be a proposed agency action order. If no timely protest to the proposed agency action is filed within 21 days of the date of issuance of the Order, this docket should be closed upon the issuance of a Consummating Order and upon receipt of the fees or cancellation of the certificate.
