- **08/29/95** - This company obtained Florida Public Service Commission Interexchange Telecommunications (IXC) Certificate No. 4065.
- **12/08/99** - The Division of Administration mailed the 1999 RAF notice. The due date was January 31, 2000.
- **02/29/00** - The Division of Administration mailed a delinquent notice.
- **11/16/00** - Mr. Robert Kiger called on behalf of IdealDial Corporation and requested information about this docket. Staff was advised that the company would pay the outstanding balance and make a settlement offer.

- **11/30/00** - The Commission received the company's check for the outstanding amount, including statutory penalty and interest charges. The company reported revenues in the amount of \$12,699 for the period ended December 31, 1999. In addition, the company proposed a settlement.
- **12/05/00** - This docket was deferred from the December 5 Agenda Conference.

The Commission is vested with jurisdiction over this matter pursuant to Sections 364.336 and 364.285, Florida Statutes. Accordingly, staff believes the following recommendations are appropriate.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission accept the settlement offer proposed by IdealDial Corporation to resolve the apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

RECOMMENDATION: Yes. The Commission should accept the company's settlement proposal. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, Certificate No. 4065 should be canceled administratively. (Isler)

STAFF ANALYSIS: After the recommendation was filed, but prior to the December 5, 2000 Agenda Conference, the Commission received the company's payment for the outstanding regulatory assessment fee, including statutory penalty and interest charges, and a letter from the company which offered to pay a \$100 contribution. In addition, the company proposed to pay future RAFs on a timely basis. This settlement amount is consistent with amounts the Commission has accepted for recent, similar violations.

Accordingly, staff believes the terms of the settlement agreement as summarized in this recommendation should be accepted. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, Certificate No. 4065 should be canceled administratively.
