period ended December 31, 1999. In addition, the company proposed a settlement.

- **10/31/00** - The Commission received the company's amended proposed settlement.

The Commission is vested with jurisdiction over this matter pursuant to Section 364.336, Florida Statutes. Accordingly, staff believes the following recommendations are appropriate.

**DISCUSSION OF ISSUES**

**ISSUE 1:** Should the Commission accept the modified settlement offer proposed by Intellicall Operator Services, Inc. d/b/a ILD to resolve the apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

**RECOMMENDATION:** Yes. The Commission should accept the company's modified settlement proposal. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, Certificate No. 5152 should be canceled administratively. (Isler)

**STAFF ANALYSIS:** After this docket was opened, but prior to staff filing a recommendation, the Commission received the company's payment for the outstanding regulatory assessment fee, including statutory penalty and interest charges, and a letter from the company which offered to pay a contribution. In addition, the company proposed to pay future RAFs on a timely basis. Staff contacted the company and explained that a specific amount needed to be proposed. On October 31, the Commission received a letter modifying its previous proposal to include an offer to pay a \$350 contribution. This settlement amount is consistent with amounts the Commission has accepted for recent, similar violations.

Accordingly, staff believes the terms of the modified settlement agreement as summarized in this recommendation should be accepted. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, Certificate No. 5152 should be canceled administratively.
