NOTICE OF WITHDRAWAL OF MOTION FOR RECONSIDERATION

NORTH FORT MYERS UTILITY, INC. ("NFMU"), by and through its undersigned attorneys, hereby notices the withdrawal of its Motion for Reconsideration of Order No. PSC-00-2349-PCO-WS ("Order") and states:

1. NFMU's Motion for Reconsideration was based upon the Commission's failure to require the Intervenors to comply with Rule 28-106.201, Florida Administrative Code, specifically the requirement that they set forth the factual basis of their objections.

2. Subsequent to filing the Motion for Reconsideration, the Intervenors admitted error in their failure to comply with Rule 28-106.201, Florida Administrative Code, by serving a letter (prepared by the Office of Public Counsel) dated December 15, 2000 setting forth what they purport to be facts supporting their position.

3. No useful purpose would be served by continuing to seek reconsideration in light of the Intervenors' substantial compliance with Rule 28-106.201, Florida Administrative Code.


