Ameritech Communications International, Inc. ("ACII") respectfully requests that the Florida Public Service Commission ("Commission") allow ACII to cancel, without prejudice, its Authority to Provide Alternative Local Exchange Service and FL PSC Price List No. 2. Consumers are not affected by canceling this authority and tariff since ACII has not provided local service in the state of Florida. ACII has paid its 1999 regulatory assessment fee and will paid the 2000 regulatory assessment fee by January 31, 2001.

ACII was granted Authority to Provide Alternative Local Exchange Service on April 15, 1997 in Docket No. 970116-TX. ACII's initial local exchange tariff was approved June 4, 1998 and was assigned Case No. T-98-0753.

On October 8, 1999, SBC Communications, Inc. merged with Ameritech Communications, Inc. The resulting corporation is known as SBC Communications, Inc. ("SBC"). The SBC subsidiary known as ACII currently receives regulatory support from Southwestern Bell Communications Services, Inc. ("SBCS"), the primary SBC subsidiary responsible for providing long distance service.

While ACII is not a provider of basic local services in the state of Florida, ACII does provide pre-paid and post-paid calling card interexchange service in the state of Florida. SBC Telecom, an affiliate of ACII, will soon offer local service in the state of Florida in accordance with the merger conditions contained in the Federal Communications Commission order which approved the SBC/Ameritech merger.

Since SBC, via SBC Telecom, will soon be offering local service in the state of Florida, it no longer made business sense for another SBC subsidiary, ACII, to also provide local service in Florida. Accordingly, as the Regulatory Director for ACII, ACII requests that the Commission cancel ACII's Authority to Provide Alternative Local Exchange Service and FL PSC Price List No. 2.
