Docket 991227-TI was opened by CMU/McCoy on 8/27/99 to cancel PREMIO Inc.'s IXC Certificate 5743 (assigned to LEG/Pena). PAA Order PSC-99-2053-PAA-TI was consummated by Order PSC-99-2239-CO-TI on 11/12/99, and Certificate 5743 was cancelled effective 8/15/99 per the PAA order.

Docket 991565-TI was opened 10/20/99 by CMU/Williams to cancel the same IXC certificate (assigned to LEG/Stern). PAA Order PSC-99-2253-PAA-TI cancelling the certificate effective 10/5/99 was issued 11/18/99 and is due for a consummating order today, 12/16/99.

The latter docket was obviously opened in error, but since it has gone through the entire process, with the exception of the consummating order being issued, I'm not sure what we should do about this.
