AMENDATORY ORDER

BY THE COMMISSION:

On November 13, 200, we issued Order No. PSC-00-2149-PAA-TC granting certificates to provide Interexchange Telecommunications certificates. This Order was consummated by Order No. PSC-00-2360-CO-TI. However, due to a scrivener's error, the caption of Order No. PSC-00-2149-PAA-TC incorrectly reflected that the above mentioned dockets were applications for Pay Telephone certificates. Further, Order No. PSC-00-2149-PAA-TC was issued with the incorrect suffix "TC," thus Consummating Order No. PSC-00-2360-CO-TI reflected also the incorrect suffix. Therefore, Order No. PSC-00-2149-PAA-TC is amended to reflect that the above mentioned dockets are applications for Interexchange Telecommunications certificates. Further, Order No. PSC-00-2149-PAA-TC and Order No. PSC-00-2360-CO-TI are amended to reflect the appropriate suffix "TI."
