ORDER MODIFYING ORDER NO. PSC-00-2064-FOF-TI

BY THE COMMISSION:

The above docket was initiated pursuant to a request for approval of an asset purchase agreement filed jointly by International Exchange Communications, Inc. d/b/a IE COM (IE COM) and NOSVA Limited Partnership (NOSVA) on January 21, 2000.

We approved the transfer of control in Order No. PSC-00-0437-PAA-TI, issued March 2, 2000 and consummated by Order No. PSC-00-0599-CO-TI issued March 28, 2000.

On August 28, 2000, our staff was notified that the transaction did not take place. Therefore, in a recommendation considered at the October 17, 2000, Agenda Conference, our staff requested that Order No. PSC-00-0437-PAA-TI, issued March 2, 2000

and consummated by Order No. PSC-00-0599-CO-TI, issued March 28, 2000, be vacated. The Commission approved staff's recommendation.

However, due to a scrivener's error, the body of staff's recommendation, incorrectly cited the order being vacated as PSC-00-0437-PAA-TP instead of PSC-00-0437-PAA-TI and incorrectly cited the consummating order as PSC 00-0599-CO-TP instead of PSC 00-0599-CO-TI. Therefore, when Order No. PSC-00-2064-FOF-TP was issued on October 27, 2000, it also incorrectly cited the consummating order being vacated as PSC-00-0599-CO-TP instead of PSC-00-0599-CO-TI.

Therefore, Order No. PSC-00-2064-FOF-TI, issued October 27, 2000, is corrected to state that the Order being vacated is PSC-00-0437-PAA-TI, not PSC-00-0437-PAA-TP and the Consummating Order being vacated is PSC-00-0599-CO-TI not PSC-00-0599-CO-TP. Accordingly, Order No. PSC-00-2064-FOF-TI is modified as set forth in the body of this Order.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-00-2064-FOF-TI is modified as set forth in the body of this Order. It is further

ORDERED that this docket shall be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
