By letter dated November 13, 2000, BellSouth Telecommunications, Inc. filed a Notice of the adoption of the Interconnection, Unbundling, Resale, and Collocation Agreement entered into between BellSouth Telecommunications, Inc. and DIECA Communications, Inc. d/b/a Covad Communications Company approved by the Commission by Order No. PSC-99-0311-FOF-TP issued February 18, 1999. Newpath Holdings is adopting the agreement and all amendments, as provided by Section 252(i) of the Telecommunications Act of 1996.

As outlined in Chapter 2.07, Section C.16 of the Administrative Procedures Manual, our review results in our recommendation that the adoption of said agreement and all amendments, approved by the Commission as of the date of issuance of the Order, by Newpath Holdings and BellSouth Telecommunications, Inc. should be approved; an administrative order be issued; and the docket be closed. The Companies shall be required to file with the Commission any amendments to the adopted agreement approved after the issuance of this Order.
