

Dear Mr. Alley:

This is a follow up to your letter dated December 21 in which you requested cancellation of your pay telephone certificate. There are two types of cancellation. The first is voluntary and is requested by the certificate holder. The Commission grants voluntary cancellations if a company is in good standing and has paid the Regulatory Assessment Fee. The other is involuntary. This is where the Commission cancels a certificate for a rule violation, such as not paying the Regulatory Assessment Fee. If the Commission cancels a certificate involuntarily, any unpaid fees, including penalty and interest charges, are forwarded to the Comptroller's Office for collection attempts. I'm enclosing a copy of Rule 25-24.514, Florida Administrative Code, for your review.

The Regulatory Assessment Fee is owed if a certificate is active for any day during a calendar year. Although you may have sold your business in 1999, the Commission was not advised, therefore, the Regulatory Assessment Fee is owed for the year 2000. Since we received your request for cancellation on December 26, 2000, I will make that date the effective date of the cancellation if your payment for the \$50 fee is postmarked by January 30, 2001.
