Dear Mr. Narducci:

This is a follow up to your \$50 settlement offer to resolve the above docket. Commission records show that the 2000 Regulatory Assessment Fee (RAF), which was due January 30, has not been received. The 2000 return is attached. Since the 2000 fee is now past due, penalty and interest charges are applicable. Please complete the 2000 return and send it, along with full payment, to the Commission by February 16. The docket number should be written on your check.

In addition, to be consistent with prior Commission decisions, I cannot recommend acceptance of your \$50 proposal. This means that you have three options. The first is to write the Commission a letter and amend your previous settlement offer to increase the proposed settlement amount to \$100. Your amended settlement should include the docket number, a statement that you wish to increase the proposed settlement amount to \$100, and a statement that all other elements in your October 19 settlement are reaffirmed. If you choose this option, I will write a recommendation to accept your settlement offer (after the amendment and the 2000 fee has been received).

The second option is to pursue your \$50 settlement offer by producing additional documentation to support your case. If you choose this option and in order for me to recommend acceptance of the offer, you must supplement the documentation (check register) that you mailed a check and the 1999 RAF return on March 31, but which was never received by the Commission. One suggestion is a copy of your bank statements showing that the check number never cleared your bank. Until the additional documentation is received and reviewed, I cannot advise you if I will recommend acceptance or denial of the proposal.

The third option is to pursue the \$50 settlement without providing the additional documentation to support your case. If you choose this option, I would write a recommendation to deny your settlement offer. If the Commissioners approved this recommendation, then the \$500 fee previously imposed would be reinstated.


