

**MOTION TO AMEND BELLSOUTH TELECOMMUNICATIONS, INC.'s  
NOTICE OF INTENT TO REQUEST TEMPORARY WAIVER OF PHYSICAL  
COLLOCATION REQUIREMENTS IN THE  
ATLANTIC RSM CENTRAL OFFICE**

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and files this Motion to Amend Notice of Intent to Request a Temporary Waiver of the Physical Collocation Requirements in the Atlantic RSM Central Office in Jacksonville, Florida.

1. On January 22, 2001, BellSouth filed its original Notice of Intent to Request a Temporary Waiver of the Physical Collocation Requirements in the Atlantic RSM Central Office in Jacksonville, Florida.
2. Pursuant to the Commission's request, BellSouth files this Motion to Amend to clarify paragraph (1) of the original Notice of Intent, which shall now read:

BellSouth is unable to fulfill a request for physical collocation in this office due to the lack of space. Currently, BellSouth has plans to complete a building addition in this office at the end of the second quarter of 2001. Once the addition is complete, there will be sufficient space to provide requesting ALECs physical collocation in this office.

3. The only change to paragraph (1) of the original Notice of Intent is that the word "completely" has been deleted and that the word "fourth" has been changed to "second."

4. The remaining paragraphs of the original Notice of Intent remain the same.
