On January 5, 2001, Domino Networks Communications, Inc. ("DNC") filed the above referenced Application. This letter is to inform the Commission that on February 1, 2001, DNC and its parent company, Domino Networks, Inc., formally changed their names to Zephion Networks Communications, Inc. 
