counties for the last 13 years. As a respondent to the jeopardy relief hearings
in 813 area code in 1997, 1998, Peggy Arvanitas was and is still concerned about
the irregularities of the GTE's interpretation of "voluntary guidelines". The
extent of the rate center / tariff issue further diminishes "Verizon's" standing
in our community, as everywhere else we are consolidating rate centers in discussions
and Verizon, being included in the Rate Center Consolidation document presented to
the Commissioners, has chosen to expand them.

4. That Verizon, with the 727/ 813 area code split should have made "business
customers" take 727 area code in Pinellas, let them keep their previous 813 area code
and this is causing the acceleration of jeopardy relief and rate center problems.


