BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request For Specified Confidential Classification for the data request on LEC/CLEC procedures for connecting former ILEC or CLEC customers.

1. In a letter dated January 9, 2001, the Florida Public Service Commission ("Commission"), requested BellSouth to provide written procedures for connecting new BellSouth customers switching their local service from a CLEC. This information is being given in connection with an informal investigation of LEC/CLEC procedures conducted by the Commission. The above information is customer-specific.

2. BellSouth is filing this Request for Confidential Classification because the information contained in this response is clearly confidential and proprietary, and therefore, entitled to confidential classification pursuant to Sections 119.07(2)(r) and 364.183, Florida Statutes.
