**VERIZON SELECT SERVICES INC.'S
NOTICE OF INTENT TO SEEK CONFIDENTIAL CLASSIFICATION**

Verizon Select Services Inc. (VSSI) (formerly, GTE Communications Corporation) gives notice of its intent to seek confidential classification of documents produced to the Office of Public Counsel in response to its Sixth Set of Requests for Production of Documents. This Notice exempts this material from section 119.07(1) of the Florida Statutes and section 24(a), Article I of the Florida Constitution and protects it from public disclosure. This information falls within Florida Statutes section 364.183(3)(e), which defines the term "proprietary confidential business information" to include "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of that information." In a competitive business, any such knowledge obtained about a competitor can be used to the detriment of the entity to which it pertains. This unfair advantage skews the operation of the market, to the ultimate detriment of the consumer.


VSSI will later file a specific request for permanent protective order, in accordance with Commission rule 25-22.006.
