NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING CERTIFICATE TO PROVIDE
INTEREXCHANGE TELECOMMUNICATIONS SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Telstar International, Inc. d/b/a Telstar USA, Inc. (Telstar USA) has applied for a certificate to provide Interexchange Telecommunications (IXC) service. Upon review of its application, it appears that Telstar USA has sufficient technical, financial, and managerial capability to provide such service, as required under Section 364.337(3), Florida Statutes. Accordingly, we hereby grant Certificate No. 7755 to Telstar USA.

If this Order becomes final and effective, it shall serve as Telstar USA's certificate. Telstar USA should, therefore, retain this Order as proof of certification.

IXC providers are subject to Chapter 25-24, Florida Administrative Code, Part X, Rules Governing Telephone Service Provided by Interexchange Telephone Companies. IXC providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapters 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to Telstar USA for payment in January. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve Telstar USA from its obligation to pay RAFs.

Based on the foregoing,

ORDERED by the Florida Public Service Commission that we hereby grant Certificate No. 7755 to Telstar International, Inc. d/b/a Telstar USA, Inc., which shall authorize it to provide Interexchange Telecommunications services, subject to the terms and conditions specified in the body of this Order. It is further


ORDERED that this Order shall serve as Telstar International, Inc. d/b/a Telstar USA, Inc.'s certificate and should be retained by Telstar International, Inc. d/b/a Telstar USA, Inc. as proof of certification. It is further
