NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELLING ALTERNATIVE LOCAL EXCHANGE AND INTEREXCHANGE
TELECOMMUNICATIONS CERTIFICATES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service
Commission that the action discussed herein is preliminary in
nature and will become final unless a person whose interests are
substantially affected files a petition for a formal proceeding,
pursuant to Rule 25-22.029, Florida Administrative Code.

Prism Florida Operations, LLC (Prism), holder of Alternative
Local Exchange Telecommunications Certificate (ALEC) of Public
Convenience and Necessity No. 7225 and Interexchange
Telecommunications Certificate (IXC) of Public Convenience and
Necessity No. 7226, has requested the cancellation of ALEC
Certificate No. 7225 and IXC Certificate No. 7226. Prism has
complied with the provisions of Rules 25-24.820(2) and 25-24.474(2),
Florida Administrative Code, by providing adequate notice in
writing of its request for cancellation of its ALEC and IXC
certificates and by submitting its Regulatory Assessment Fees
(RAFs) for the year 1999. Accordingly, we find it appropriate to

cancel ALEC Certificate No. 7225 and IXC Certificate No. 7226, effective January 5, 2001. Prism shall return to this Commission the Order granting authority to provide ALEC services and IXC services. The Commission is vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.337, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2000 has been mailed to Prism and a RAF Return for the year 2001 will be mailed to Prism. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2000 or 2001 shall relieve Prism from its obligation to pay RAFs for the years 2000 or 2001.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Prism Florida Operations, LLC's Certificate No. 7225 to provide Alternative Local Exchange Telecommunications services and Certificate No. 7226 to provide Interexchange Telecommunications services are hereby canceled, effective January 5, 2001. It is further


ORDERED that Prism Florida Operations, LLC shall return to this Commission the Orders granting authority to provide Alternative Local Exchange Telecommunications services and Interexchange Telecommunications services and remit Regulatory Assessment Fees for the years 2000 and 2001. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

The action proposed herein is preliminary in nature. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code.
