As part of a new business plan, TWC stopped providing service to its
ALEC, Switchless Rebiller, and Shared Tenant Services customers on or about
March 31, 2000. All customers were given thirty (30) days written notice prior to
discontinuance of their service. Refunds and deposits have been returned to all
customers, and final customer bills have been resolved except for a small
number that remain in the collection process.




