By Order No. PSC-99-0252-FOF-WS, issued February 9, 1999, Docket No. 981241-WS was to remain open pending final disposition of all issues in Docket No. 981022-WS. Once that docket had been administratively closed, Certificate Nos. 223-W and 167-S were to be canceled and Docket No. 981241-WS administratively closed, as well.
