NOTICE OF PROPOSED AGENCY ACTION  
ORDER APPROVING TRANSFER OF CONTROL

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated January 3, 2001, The Basico Group, Inc. (Basico) and Oronoco Networks, Inc. (Oronoco) filed with this Commission an application for approval of transfer of certificates

from Basico to Oronco. Basico is the holder of Alternative Local Exchange Telecommunications (ALEC) Certificate No. 7218 and Interexchange Telecommunications (IXC) Certificate No. 7383. Basico has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided. Basico has stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of Basico and Oronco, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. The Commission is vested with jurisdiction over this matter pursuant to Sections 364.335 and Sections 364.33, Florida Statutes.

Based on the foregoing, it is,


ORDERED by the Florida Public Service Commission that The Basico Group, Inc. and Oronco Networks, Inc.'s request for approval of transfer of control of Certificate Nos. 7218 and 7383 from The Basico Group, Inc. to Oronco Networks, Inc. is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto.
