NOTICE OF PROPOSED AGENCY ACTION  
ORDER IMPOSING FINE AND REQUIRING PAYMENT OF DELINQUENT  
REGULATORY ASSESSMENT FEES AND REQUIRING INFORMATION IN  
ACCORDANCE WITH RULE 25-24.835, FLORIDA ADMINISTRATIVE CODE,  
OR CANCELING ALTERNATIVE LOCAL EXCHANGE TELECOMMUNICATIONS  
CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service  
Commission that the action discussed herein is preliminary in  
nature and will become final unless a person whose interests are  
substantially affected files a petition for a formal proceeding,  
pursuant to Rule 25-22.029, Florida Administrative Code.

YourTel Telecom Corporation (YourTel) currently holds  
Certificate of Public Convenience and Necessity No. 5762, issued by

the Commission on August 30, 1999, authorizing the provision of Alternative Local Exchange Telecommunications services (ALEC). The Division of Administration advised our staff by memorandum that YourTel had not paid the Regulatory Assessment Fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the years 1999 and 2000. Also, accrued statutory penalties and interest charges for late RAFs payments for the years 1999 and 2000 had not been paid.

Pursuant to Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. All entities that apply for certification receive a copy of our rules governing ALEC service.

Pursuant to Section 350.113(4), Florida Statutes, the RAFs forms, for the period of January 1, through December 31, are mailed to entities at least 45 days prior to the date that payment of the fee is due. YourTel has been given adequate opportunity to pay. To date, YourTel has not paid the required fees.

The Commission's correspondence regarding the RAFs was returned by the United States Postal Service. The return of these materials indicates that YourTel may have violated Rule 25-24.835, Florida Administrative Code, which requires the reporting to the Commission of an address change and/or a change in the name, title, or telephone number of the individual responsible for Commission contacts, within 10 days of its effectiveness. It has been well over 10 days and YourTel has not provided the information required by Rule 25-24.835, Florida Administrative Code, nor has it requested cancellation of its certificate in compliance with Rule 25-24.820 (2), Florida Administrative Code.

For the reasons described above, pursuant to Rule 25-24.820(1)(b) and (c), Florida Administrative Code, we find it appropriate to cancel YourTel's certificate for failure to pay RAFs pursuant to Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, unless YourTel pays a \$500 fine and remits all past due RAFs, along with accrued statutory penalties and interest charges, to the Florida Public Service Commission. also find it appropriate to cancel YourTel's certificate for failure to comply with Rule 25-24.835, Florida Administrative Code, unless YourTel pays a \$500 fine and provides the information required by Rule 25-24.835, Florida Administrative Code, to the Florida Public Service Commission. YourTel must comply with these requirements within five business days after the date of issuance of the Consummating Order. The payment should be identified with the docket number and the entity's name. The two fines, totaling \$1,000, will be remitted to the Comptroller for deposit in the State of Florida General Revenue Fund, pursuant to Section 364.285 (1), Florida Statutes.

When the appropriate fees, statutory penalties, interest charges, and fine are received, this Docket shall be closed. Should YourTel fail to comply with this Order within five business days after the date of issuance of the Consummating Order, YourTel shall have its certificate canceled, effective on the date of issuance of the Consummating Order, the collection of the past due fees shall be referred to the Office of the Comptroller for further collection efforts, and the Docket shall be closed. The cancellation of the certificate and the closing of the Docket in no way diminishes YourTel's obligation to pay applicable delinquent RAFs, and accrued statutory penalties and interest charges. The Commission is vested with jurisdiction over this matter pursuant to Sections 364.336, 364.337 and 364.285, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that YourTel Telecom Corporation must pay the past due Regulatory Assessment Fees, statutory penalties, interest charges, and a \$500 fine to the Florida Public Service Commission for failure to comply with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, within five business days after the date of issuance of the Consummating Order. The fine will be transmitted to the Comptroller for deposit in the State of Florida General Revenue Fund. It is further

ORDERED that YourTel Telecom Corporation must provide the correct mailing address, liaison information, and other information in accordance with Rule 25-24.835, Florida Administrative Code, and pay a \$500 fine to the Florida Public Service Commission for

failure to comply with Rule 25-24.835, Florida Administrative Code, within five business days after the issuance of the Consummating Order. The fine will be transmitted to the Office of the Comptroller for deposit in the State of Florida General Revenue Fund. It is further

ORDERED that pursuant to Rule 25-24.820(1)(b), Florida Administrative Code, should YourTel Telecom Corporation fail to comply with this Order, YourTel Telecom Corporation's Certificate No. 5762 shall be canceled, effective on the date of issuance of the Consummating Order, the collection of the past due fees shall be referred to the Office of the Comptroller for further collection efforts, and the Docket shall be closed. It is further


ORDERED that the cancellation of the certificate and the closing of the docket in no way diminishes YourTel Telecom Corporation's obligation to pay applicable delinquent Regulatory Assessment Fees, and accrued statutory penalties and interest charges. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed upon payment of the fine, and fees, or upon cancellation of the certificate.
