This shall confirm our conversation earlier this week wherein I advised you that after several months of confusion as to where Mr. Viau's estate would be probated, i.e. Florida or Canada; it was determined that the probate of Mr. Viau's estate would take place in Canada. That process is now underway and I advised you that the estate of Henri Viau is the financially responsible party for the utility. I am advised that the estate has sufficient liquid assets and revenues to maintain the facility to the standards required by law.
