Dear Ms. Bayo:

On January 29, 2001, Sprint filed a Petition for Temporary Waiver of Physical Collocation at the Maitland Central Office. The Petition requests the waiver of physical collocation at the Maitland Central Office until May 1, 2001 due to technical constraints that rendered provisioning of collocation infeasible.

Because the requested waiver date is now within the 90 day provisioning interval for physical collocation required by the Commission, Sprint is no longer denying applications for physical collocation at the Maitland Central Office. Therefore, by this letter Sprint respectfully requests that its Petition for Waiver be withdrawn. . (A copy of the notification of availability of collocation at the Maitland Central Office that was sent by Sprint to ALECs previously placed on an informal waiting list for space is attached.) Previously you had applied for collocation at the MTLDFLXA office and had agreed to place your application on a waiting list pending the completion of a planned building addition to that office.

In accordance with the Florida Public Service Commission's requirements, this is the sixty (60)-day advance notification of space availability and the re-opening of the office. The building addition is complete and necessary space preparation activities for this office will be completed on May 1, 2001

An updated application with new requirements and fee, if part or all of your original application was refunded, will need to be submitted. If your existing application, fee and previously requested requirements are still valid, you will need to notify Sprint in writing that the application is valid and you want to proceed. Your Sprint Local Account Manger must receive either the new application or written confirmation (via US Mail or e-mail) to proceed before or on April 1, 2001 or you will be dropped from the waiting list.

Responses received from you for applications on the waiting list will be processed by Sprint in the order they are received and consistent with the Florida Commission's collocation orders (i.e., a price quote will be provided within 15 days of receipt of your response). Applications will be worked until all available space has been offered to all applicants on the waiting list.

Upon receipt of your firm order, based on the price quote aforementioned, Sprint will provision your new space requirements within the time frames required by the Florida Commission, that is, within 90 days for new space and within 45 days for augments.


