Pursuant to Section 350.113(4), Florida Statutes, the RAFs forms, for the period of January 1, through December 31, are mailed to the entities at least 45 days prior to the date that payment of the fee is due. Comtel Network was scheduled to remit its RAFs by January 31, 2000.

On December 20, 2000, we issued Order No. PSC-01-0002-PAA-TI to impose a \$500 fine. Failure to comply or respond to this Order would result in the cancellation of Comtel Network's certificate. Comtel Network has since paid the 1999 RAFs, including accrued statutory penalties and interest charges, offered to contribute \$150 to the State General Revenue Fund, and proposed to pay future RAFs on a timely basis.

We believe that the terms of the settlement agreement represent a fair and reasonable resolution of this matter. Accordingly, we hereby accept the settlement offer. Comtel Network must comply with these requirements within ten business days from the date this Order becomes final. The contribution should be identified with the docket number and the company name. Upon timely receipt, the contribution will be forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If Comtel Network fails to comply with this Order, its certificate will be canceled administratively. Upon remittance of the \$150 contribution or cancellation of the certificate, this docket shall be closed. The Commission is vested jurisdiction over this matter pursuant to Sections 364.336, 364.337, and 364.285, Florida Statutes.
