Dear Ms. Bayo:

SBC National, Inc. d/b/a SBC Telecom, Inc. is the holder of alternative local exchange company ("ALEC") Certificate of Public Convenience and Necessity No. 7030 and interexchange company ("IXC") Certificate of Public Convenience and Necessity No. 7492.

On November 10, 1999, SBC National, Inc. filed a name change amendment with the Florida Department of State changing the company's name to SBC Telecom, Inc., which name change was effective October 19, 1999 in Delaware, the company's state of incorporation. A copy of this filing is attached hereto as Composite Exhibit "A." The Florida Department of State notified SBC National, Inc. that the name SBC Telecom, Inc. was not available in Florida at that time because it had been used by another corporation, but that SBC National, Inc. could use SBC Telecom, Inc. as a fictitious name. Accordingly, on December 6, 1999, SBC National, Inc. registered the fictitious name SBC Telecom, Inc. with the Florida Department of State. The company notified the Florida Public Service Commission (the "Commission") of the use of this fictitious name and the name change was reflected on ALEC Certificate No. 7030 by Order No. PSC-00-0662-FOF-TX issued

April 17, 2000. The Commission subsequently granted SBC National, Inc. d/b/a SBC Telecom, Inc. IXC Certificate No. 7492 by Order No.PSC-1146-PAA-TI issued June 23, 2000.

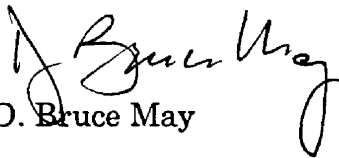
On November 14, 2000, after the corporate name SBC Telecom, Inc. became available for use again in Florida, the company filed another name change amendment with the Florida Department of State to drop the fictitious name SBC Telecom, Inc. A copy of this filing is attached hereto as Composite Exhibit "B." Accordingly, the company's name in Florida is no longer SBC National, Inc. d/b/a SBC Telecom, Inc., but is simply SBC Telecom, Inc. Please amend ALEC Certificate No. No. 7030 and IXC Certificate No. 7492 to reflect the change in the name of the company holding such certificates from SBC National, Inc. d/b/a SBC Telecom, Inc. to SBC Telecom, Inc.

This is only a name change, and does not involve any change in majority organizational control or other change in ownership. To facilitate changing the name SBC National, Inc. d/b/a SBC Telecom, Inc. to SBC Telecom, Inc. on the company's ALEC price list and IXC tariff we are attaching labels reflecting the new name that can be affixed to the price list and tariff.

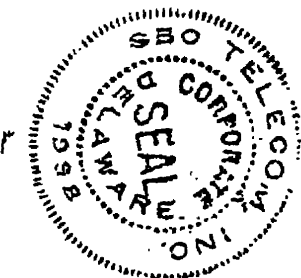
