3. <u>Statement of Substantial Interests</u>. The FCCA is an industry organization composed of carriers and associations of carriers who advocate the formulation and adoption of policies that would foster the development of competition in all telecommunications markets. The FCCA was formed for the purpose of articulating its members' positions on matters affecting the framework for competition in proceedings before the Florida Public Service Commission. In this proceeding, the Commission will consider whether, in the interest of the development of a competitive local exchange market, it should require BellSouth Telecommunications, Inc. ("BellSouth") to form separate wholesale and retail entities. The subject of the development and eventual flourishing of competition in Florida's local exchange market. The decision of the Commission in this docket will affect the competitive posture of FCCA's members. Intervening for the purpose of communicating its members' positions and views on the subject of the docket is consistent with the purpose of FCCA and appropriate for an organization such as FCCA to undertake.

4. <u>Statement of Disputed Issues of Material Fact</u>: While the disputed issues of material fact cannot be identified with certainty at this point, FCCA anticipates that BellSouth may dispute that a need exists to impose structural separation on BellSouth. FCCA reserves the right to address these and other issues as its interests may require.

5. <u>Ultimate Facts Alleged</u>: BellSouth's disincentives to serve its competitors timely and efficiently has rendered competition in the local exchange market non-viable in Florida. Structural separation is needed to remove such disincentives. FCCA's position is set forth in more detail in FCCA's Request for Commission Investigation Concerning the Use of Structural Incentives to Open Local Telecommunications Markets in Support of AT&T's Petition to Initiate Proceeding, which is
