Ms. Masterton and Mr. Yovanovich:

Please be advised that the Notice of Adoption of SATCOM Communication Corporation and Sprint Resale Agreement by Sandhills Telecommunications Group, Inc. d/b/a SanTel Communications, Docket 010369, filed March 28, 2001 must either be withdrawn or amended to correctly identify certificated parties.

While Sandhills Telecommunications Group, Inc. is certificated with both the Secretary of State, Division of Corporations and the Florida Public Service Commission, the corporate name Sandhills Telecommunications Group, Inc., d/b/a SanTel Communications is not certificated with the Commission.

Pursuant to Commission Rules, as well as meetings held with Sprint and other ILECs, parties to an agreement filed with the FPSC must be certificated with the Commission under the EXACT name as identified in FPSC records. I am aware that both Sandhills Telecommunications Group, Inc. and SanTel are

registered with the Secretary of State, however, no d/b/a identity exists with the Commission.

To that end, three options are available: 1) withdraw the filing in its entirety and refile upon completion and approval of FPSC registration/certification requirements; 2) correct Sandhills' certification to include the d/b/a and submit an "amendment" to the current filing; or 3) the Commission denies the agreement because Sandhills Telecommunications Group, Inc. d/b/a SanTel Communications is not authorized to do business as a telecommunications carrier, pursuant to state certification rules.

Should you choose either option 1 or 2 as described above, please do so not later than Monday, April 30, 2001.
