International Telecom, Ltd. (ITL) obtained Certificate No. 5531 on December 17, 1997, to provide Alternative Local Exchange (ALEC) service. On July 6, 2000, Commission Staff mailed a certified letter requesting information necessary for inclusion in the 2000 Local Competition Report required of the Commission by Section 364.386, Florida Statutes. Our staff requested a response by August 10, 2000. After receiving no response to its letter our staff opened this docket on January 30, 2001, to investigate whether ITL should be required to show cause why it should not be fined \$10,000 or have its certificate canceled for apparent violation of Section 364.183(1), Florida Statutes, Access to Company Records.

After this docket was opened, on February 13, 2001, Sandra Adix, representative of ITL, called our staff to discuss the docket and on March 6, 2001, ITL proposed a settlement of \$3,500 to resolve the case. We believe that the terms of the settlement agreement represent a fair and reasonable resolution of this matter. Accordingly, we hereby accept the settlement offer. ITL must comply with these requirements within ten business days from the date this Order becomes final. The contribution should be ___identified with the docket number and the company name. COM ___timely receipt, the contribution will be forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. ITL has waived any objection to the administrative cancellation of its certificate
