



BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. On April 5, 2001, Covad Communications Company ("Covad") served its First Set of Interrogatories and First Request for Production on BellSouth. On April 16, 2001, BellSouth filed its Objections to that discovery and on April 25, 2001, BellSouth served its Responses and Objections to that discovery.

2. However, the information contained in some of BellSouth's Responses to Covad's First Request for Production, specifically Nos. 7, 18, 22, 32 and 33, include, but is not limited to, confidential business information that is proprietary under Florida Statutes, Sections 364.183 and 364.24.

3. Because this information is proprietary, BellSouth is now filing this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of BellSouth's Responses without delay.
