Dear Ms. Bayo:

On November 2, 2000, the Florida Public Service Commission (Commission) issued Order No. PSC-00-2090-PAA-TI in the above referenced docket accepting USLD Communications, Inc.'s (USLD) settlement offer to resolve the alleged violations of Commission rules regarding inadvertent overcharges of intrastate 0+ calls made from pay telephones. Pursuant to that order, USLD is required to file a preliminary report to the Commission by April 30, 2001 on its progress with implementing the terms of the September 12, 2000 settlement offer and subsequent Commission order. The final report is due by July 1, 2001.

The above order required USLD to refund to individual customers the overcharges of \$33,718.50 plus interest of \$3,094.87 for a total of \$36,813.37. Any portion of that amount that the company is unable to refund to customers must be remitted to the Commission by July 1, 2001.

This letter serves as the interim report required by the order. To date, USLD has issued refunds to 119,539 customers for a total of \$29,884.75. There are 15,335 billing records that have resulted in unrefundable overcharges of \$3,833.75. This was due to rejected or unusable billing records.

FISCAL RECORDS REPORTING
