**NOTICE OF ENTRY OF ORDER CONFIRMING SECOND AMENDED  
JOINT PLAN OF LIQUIDATION AND OCCURRENCE OF THE  
EFFECTIVE DATE UNDER CHAPTER 11 OF THE BANKRUPTCY CODE**

**NOTICE IS HEREBY GIVEN THAT:**

1. On April 20, 2001, the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") entered an Order Confirming the Second Amended Joint Plan of Liquidation of Sabratek Corporation, CMS Healthcare, Inc., GDS Technology, Inc., and WFW Cardiac, Inc., f/k/a LifeWatch, Inc. and the Statutory Creditors' Committee Under Chapter 11 of the Bankruptcy Code (the "Confirmation Order"). The Confirmation Order confirms the Second Amended Joint Plan of Liquidation (the "Plan") proposed by Sabratek Corporation, CMS Healthcare, Inc., GDS Technology, Inc. and WFW Cardiac, Inc. f/k/a LifeWatch, Inc. and the Statutory Creditors' Committee. The debtor Unitron Medical Communications, Inc. d/b/a Moon Communications, Inc. was not included in the Plan. Copies of the Confirmation Order and the Plan are on file with the Clerk of the United States Bankruptcy Court for the District of Delaware, 824 Market Street, Wilmington, Delaware 19801, and may be reviewed during the Court's regular business hours. Unless otherwise defined in this notice, capitalized terms used in this notice shall have the meanings ascribed to them in the Confirmation Order and the Plan.

2. May 1, 2001 was the Effective Date of the Plan.

3. Pursuant to the Plan, any claims arising from the rejection of an executory contract or unexpired lease of real property will be forever barred unless a proof of claim is Filed with the Bankruptcy Court at the address referenced in paragraph one and served on counsel for the Debtors and the Committee at the addresses listed below so it is actually received by the earlier of (i) thirty (30) days after the date of entry of an order approving such rejection and (ii) May 31, 2001.

Except to the extent that another Bar Date applies pursuant to an order of the Bankruptcy Court, any petition for allowance of a Professional Fee Claim must be Filed with the Bankruptcy Court at the address referenced in paragraph one and served on counsel for the Debtors and the Committee at the addresses listed above, so that it is actually received no later than May 21, 2001, or such claim shall be forever barred and shall not be enforceable against the Debtors, their successors, their assignees or their property.
