
Dear Ralph:

CUSTOMER NOTICE

On February 9, 2000, Aloha Utilities, Inc., applied to the Florida Public Service Commission (PSC) for increased wastewater service rates resulting from construction of new treatment components related to its reuse system required by the Florida Department of Environmental Protection (DEP) and applicable to service provided to its customers in the Seven Springs area in Pasco County, Florida.

At its regularly scheduled Agenda Conference held on April 3, 2001, the Florida Public Service Commission took final action on Aloha's application and authorized a portion of the requested increases in wastewater rates designed to allow Aloha Utilities, Inc. the opportunity to recover costs for providing service and a reasonable rate of return on its investment in facilities necessary to provide such wastewater service.

The Commission issued Order No. PSC-01-0326-FOF-SU on February 6, 2001 reflecting this decision. That Order has now become final.

The increased rates approved by the Commission are effective for meters read on or after thirty (30) days from May _____, 2001.

The new rates for wastewater service are listed on the back of this customer notice.

Because Aloha implemented rates effective in December of 2000 which were above those ultimately determined to be appropriate by the Commission, all customers receiving service during this period of time will be receiving a small credit in the near future. The Utility is working with the Public Service Commission staff to calculate the exact amount of that credit, and that credit will be calculated into your bill in the next 3-4 months.
