**THIS LETTER CONSTITUTES A PETITION CONCERNING RULE 28-106.01 OF THE FLORIDA ADMINISTRATIVE CODE. ORDER 24546 ISSUED MAY 20, 1991 REQUIRED THAT PER LINE BLOCKING BE MADE TO CERTAIN SPECIFIC AGENCIES. ORDER NUMBER PSC-93-1310-FOF-TL ISSUED SEPTEMBER 9, 1993 EXTENDED PER-LINE BLOCKING TO INDIVIDUALS WHO WORKED FOR THE AGENCIES.**

**THE AFOREMENTIONED EXTENDED PER-LINE BLOCKING TO INDIVIDUAL CRISIS INTERVENTION WORKERS WHO WORKED FOR AGENCIES, BUT DID NOT ADDRESS THOSE PERSONS WHO WORKED PRIVATELY. I WORK AS A PRIVATE LICENSED MENTAL HEALTH PROFESSIONAL DOING MUCH WORK WITH LAW ENFORCEMENT DEPARTMENTS. I WORK WITH FAMILIES IN CRISIS HAVING DELINQUENT OR OTHER FAMILY MEMBERS IN CRISIS. SOME OF THESE CASES INVOLVE DOMESTIC VIOLENCE AS WELL. IT APPEARS TO ME THAT PRIVATE PRACTICE PRACTITIONERS SHOULD BE AFFORDED THE SAME RIGHTS AS THOSE AFFILIATED WITH LAW ENFORCEMENT AND AGENCIES AFFILIATED/RELATED WITH THEM. THE PROBLEMS ENCOUNTERED WOULD BE MUCH THE SAME, AND THE ANONYMITY WOULD BE JUST AS NECESSARY.**

**THIS PETITION FOR PER-LINE BLOCKING FROM SPRINT IS THEREFORE REQUESTED FROM YOU. MY EFFORTS TO OBTAIN THIS FROM SPRINT HAVE NOT BEEN SUCCESSFUL, AS THEY QUOTE YOUR ORDER STATING THAT THIS PRIVILEGE APPLIES ONLY TO AGENCY PERSONNEL. MY TELEPHONE NUMBER IN FT.
