Dear Ms. Christensen:

There is one small detail concerning the deletion of Holiday Mall from Floralino Properties' service area that I would like to call to your attention before the Agenda Conference. We would like for the order deleting the territory to specify an effective date of deletion that allows enough time to complete construction of the new interconnection.


I am assuming that a final order will be issued around June 18th (20 days after the Agenda Conference). Pasco County needs about four (4) months after the approval of deletion to complete its part of the work. The construction on Holiday Mall's portion of the new waterline should be completed within the same time. Thus, all of the work would be completed about six weeks before the temporary fire service agreement with Pasco County expires. In any construction project, however, delays can arise.

For the foregoing reason, we would request that the effective date of deletion be expressed as follows: "November 28, 2001, or 10 days after notice that the interconnection with Pasco County has been completed, whichever is earlier."

If you have any questions or comments that we should discuss before the Agenda Conference, please let me know. I will be present and will be prepared to address the Commission on this point. Otherwise, I would have no comment except to ask the Commission to follow through with the Staff's recommendation.

Thank you for your hard work and patience on this matter.


