REGULATORY AND REPORTING

Staff seeks to make the following minor oral modifications by adding the following language to Issues 1 and 2:

Issue 1: "The effective date of the deletion should be November 28, 2001, or 10 days after notice that the interconnection with Pasco County has been completed, whichever is earlier. The utility should be required to file the appropriate revised tariff sheets reflecting the deletion of territory within 30 days of the issuance date of the Order, and the tariffs should be stamped approved upon staff's verification that the interconnection with the County has been completed."

Issue 2: "The docket should be administratively closed upon staff's verification that the interconnection with the County has been completed."

Subsequent to the filing of the recommendation, Holiday Mall's counsel requested clarification of the effective date of the deletion. Staff believes that this minor modification will prevent the customer from being cutoff from water service while the the necessary lines are being constructed to be connected with the County. Further, staff would not recommend deferral of this item for this modification because a delay in Commission action would result in a delay in the beginning the necessary construction. Currently, there is approximately 5 1/2 months in which to complete this construction. Moreover, the customer indicated that the County would not being its part of the construction without an Order from the Commission.

The related modification to staff's analysis will also be made. Staff has prepared a type and strike version of the recommendation which will be provided to the appropriate persons today. Thank you.

Staff is requesting permission to make the following minor modification at agenda: "The effective date of the deletion should be November 28, 2001, or 10 days after notice that the interconnection with Pasco County has been completed, whichever is earlier."

Staff is requesting this minor oral modification for the following reasons. Susan Fox, the attorney representing the mall which is to be deleted from the territory, sent a letter subsequent to the filing of the recommendation asking for clarification of the effective date of the deletion. Ms. Fox has stated that the County needs a final order deleting the territory before it will be construction. Therefore, she is requesting a specified effective date which allows enough time to complete construction of the new interconnection between the mall and the County before water service is terminated by the current utility.
