**JOINT MOTION FOR EXTENSION OF TIME**

**NOW** comes Sprint Communications Company Limited Partnership (“Sprint”) and BellSouth Telecommunications Inc. (“BellSouth”), who jointly ask this Commission for a thirty (30) day extension of time, or until July 7, 2001, in which to execute and file an interconnection agreement. Pursuant to Order No. PSC-01-1095-FOF-TP, the parties are required to file a final executed agreement with the Commission on June 7, 2001. The parties need additional time to negotiate the final agreement. As both parties are seeking this extension, no party will be prejudiced by the granting of an additional thirty (30) days in which to file a final interconnection agreement with the Commission.

**WHEREFORE**, for the foregoing reasons, Sprint and BellSouth respectfully request that this Commission grant them an additional thirty (30) days or until July 7, 2001 in which to file an executed, final interconnection agreement.


