
**PETITION OF VERIZON FLORIDA INC. FOR APPROVAL OF

This Amendment No. 1 (this "Amendment") is made this 25TH day of May, 2001 (the "Effective Date") by and between Florida Consolidated Multi-Media Services, Inc., d/b/a Florida Multi Media ("FMM"), a Florida corporation with offices at 100 Riverwind Way, Oviedo, FL 32765, and Verizon Florida Inc., f/k/a GTE Florida Incorporated ("VZ"), a Florida corporation with offices at 201 N. Franklin St., Tampa, FL 33602-5167, (each of VZ and FMM being individually, a "Party" and, collectively, the "Parties").

**WITNESSETH:**

WHEREAS, VZ and FMM are Parties to an Interconnection Agreement under Sections 251 and 252 of the Telecommunications Act of 1996 approved by the Florida Public Service Commission ("Commission") on March 26, 2001 (the "Interconnection Agreement");

WHEREAS, the Parties desire to provide FMM with access to the E911 network systems and databases established and maintained by VZ in a technically and economically efficient manner sufficient to enable FMM to provide E911 service to its end user customers; and

WHEREAS, the Parties wish to amend the Interconnection Agreement to provide pricing that will allow FMM to provide E911 to its end user customers using the systems and databases established and maintained by VZ;

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Interconnection Agreement as follows:

The following replaces Pricing Attachment Appendix A, Section 4 of the Interconnection Agreement in its entirety


