#### **BACKGROUND**

- 1. On April 2, 2001 (the "Petition Date"), the Debtors filed voluntary petitions in the United States Bankruptcy Court for the District of Delaware under Chapter 11 of the Bankruptcy Code. The case was captioned, In re Pathnet Telecommunications, Inc. et al.. Case No. 01-1223 (PJW). On May 18, 2001, the Delaware Bankruptcy Court transferred venue to this Court. The Debtors continue to operate their businesses and manage their properties as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 2. PNI was formed on August 25, 1995, under the laws of the State of Delaware. It is a wholesale telecommunications provider and has built a network designed to provide other wholesale and retail telecommunications service providers with access to underserved and second- and third-tier markets throughout the United States.
- 3. PTI was formed on November 1, 1999, under the laws of the State of Delaware, by the former shareholders of PNI to facilitate a corporate reorganization transaction, which became effective on March 30, 2000, and to continue the activity of PNI. Upon finalization of the corporate reorganization transaction, PNI became a wholly-owned subsidiary of PTI.
- 4. POI was formed on April 6, 2000, under the laws of the State of Delaware, to facilitate the development of the Pathnet Group's fiber optic business. POI is a wholly owned subsidiary of PTI.
- 5. POV was formed on June 26, 2000, under the laws of the Commonwealth of Virginia, to hold certain licenses used in the development of the Debtors' fiber optic business. POV is a wholly-owned subsidiary of POI.

- 6. PFE was formed on June 23, 2000, under the laws of the State of Delaware, to hold certain fiber assets used in the development of the Debtors' fiber optic business. PFE is a wholly owned subsidiary of POI.
- 7. PRE was formed on June 23, 2000, under the laws of the State of Delaware, to hold certain real estate assets used in the development of the Debtors' fiber optic business. PRE is a wholly owned subsidiary of POI.
- 8. The Pathnet Group's telecommunications network is intended to enable its customers, including existing local telephone companies, long-distance companies, internet service providers, competitive telecommunications companies, cellular operators and other telecommunications providers, to offer additional services to new and existing customers in the markets the Pathnet Group serves without having to expend their own resources to build, expand or upgrade their own networks.
- 9. As of February 28, 2001, the Pathnet Group employed approximately 255 employees. Immediately prior to the Petition Date, the Pathnet Group, in a cost-saving measure, terminated the employment of approximately 17% of its employees. As of the Petition Date, the Debtors employed approximately 207 employees.
- 10. As of December 31, 2000, the Pathnet Group reported approximately \$298 million in assets and approximately \$472 million in liabilities on a consolidated basis.
- 11. As of December 31, 2000, the Pathnet Group's network consisted of over 6,300 wireless route miles providing wholesale transport services and 1,400 miles of installed fiber, with collocations in 73 cities.

- 12. The Debtors were forced to file for Chapter 11 protection because, despite diligent efforts, they have been unable to obtain sufficient capital to fund operating shortfalls while the Pathnet Group's telecommunications network is being developed.
- 13. On or about April 19, 2001, the United States Trustee appointed an official committee of unsecured creditors in the above-captioned cases.
- 14. Pursuant to 28 U.S.C. § 1334, the Court has jurisdiction over this Motion. which is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2). Venue of the Debtors' Chapter 11 cases and this Motion is proper in this district under 28 U.S.C. §§ 1408 and 1409. The statutory predicate for the relief sought herein is 11 U.S.C. § 365(d)(4).

#### RELIEF REQUESTED

15. The Debtors respectfully request the entry of an interim order extending the time to assume or reject their unexpired leases of nonresidential real property through and including such date and time as the Court enters an order with respect to the Motion to Extend.

#### **BASIS FOR RELIEF**

16. As more fully described in the Motion to Extend, the Debtors are lessees under numerous unexpired leases of nonresidential real property located throughout the United States (collectively, the "Leases"). The Leases are listed on Exhibit A to the Motion to Extend.<sup>2</sup>

Nothing in this Motion or the Motion to Extend constitutes an admission by the Debtors that any of the Leases constitute a true lease. The Debtors reserve their right to challenge the characterization of any of the Leases, and seek this extension of time to assume or reject the Leases out of an abundance of caution.

<sup>&</sup>lt;sup>2</sup> The list of leases on **Exhibit A** is not intended to be an exhaustive list of the Debtors unexpired leases of nonresidential real property, but merely represents the leases identified by the Debtors as of the date of this Motion. By this Motion, the Debtors seek an interim order extending the time to assume or reject all unexpired leases of nonresidential real property. Nothing herein is (continued...)

- assumption or rejection by the Debtors under § 365(a) of the Bankruptcy Code. 11 U.S.C. § 365(a). Section 365(d)(4), however, places certain time limitations on a debtor's ability to assume or reject an unexpired lease of nonresidential real property. In particular, § 365(d)(4) states, "if the trustee does not assume or reject an unexpired lease of nonresidential real property under which the debtor is the lessee within 60 days after the date of the order for relief, or within such additional time as the court, for cause, within such 60-day period, fixes, then such lease is deemed rejected . . ." 11 U.S.C. § 365(d)(4). The initial 60-day period in this case (the "Assumption/Rejection Period") will expire on or about June 1, 2001.
- § 365(d)(4) as long as the debtor files a motion for an extension before the initial 60 days expire.

  See In re Southwest Aircraft Services. Inc., 831 F.2d 848, 853 (9th Cir. 1987); In re Pier 5

  Management Co., Inc., 83 B.R. 392, 394 (Bankr. E.D. Va. 1988) (noting that "issue would be moot had Pier 5 timely moved the Court for an extension of time to assume or reject the lease at issue") (emphasis added); In re Channel Home Centers, Inc., 989 F.2d 682, 688 (3d Cir. 1993)

  ("We believe that Congress meant to require that initial extensions be sought before the 60-day period expired . . .") (emphasis added). A minority of courts, however, hold that the judge must actually grant the extension within the initial 60-day period. Debartolo Properties Management v. Devan, 194 B.R. 46, 52 (D. Md. 1996).

intended to be a waiver, release, or impairment of any and all of the Debtors' rights, claims and defenses with respect to the Leases, and the Debtors intend to reserve and enforce their rights, claims, and defenses relating to the Leases to the full extent of the law.

19. The Debtors believe that § 365(d)(4) authorizes an extension as long as they file a motion within the Assumption/Rejection Period. However, out of an abundance of caution, the Debtors seek this interim or "bridge" order granting an extension until the Motion to Extend is decided. Courts routinely grant such bridge orders.

20. For the reasons discussed in the Motion to Extend, the Debtors have "cause" for this interim extension, and the landlords will not be prejudiced by this interim extension.

#### **NO PRIOR REQUEST**

21. No previous application for the relief requested herein has been made to this or any other court.

WHEREFORE, the Debtors respectfully request that the Court enter an interim order extending the time to assume or reject their unexpired leases of nonresidential real property from the current deadline set forth in § 365(d)(4) through and including such date and time as the Court enters an order with respect to the Motion to Extend.

PTI was formed on November 1, 1999, under the laws of the State of Delaware, by the former shareholders of PNI to facilitate a corporate reorganization transaction, which became effective on March 30, 2000, and to continue the activity of PNI. Upon finalization of the corporate reorganization transaction, PNI became a whollyowned subsidiary of PTI.
- 4. POI was formed on April 6, 2000, under the laws of the State of Delaware, to facilitate the development of the Pathnet Group's fiber optic business. POI is a wholly owned subsidiary of PTI.
- 5. POV was formed on June 26, 2000, under the laws of the Commonwealth of Virginia, to hold certain licenses used in the development of the Debtors' fiber optic business. POV is a wholly-owned subsidiary of POI.

- 6. PFE was formed on June 23, 2000, under the laws of the State of Delaware, to hold certain fiber assets used in the development of the Debtors' fiber optic business. PFE is a wholly owned subsidiary of POI.
- 7. PRE was formed on June 23, 2000, under the laws of the State of Delaware, to hold certain real estate assets used in the development of the Debtors' fiber optic business. PRE is a wholly owned subsidiary of POI.
- 8. The Pathnet Group's telecommunications network is intended to enable its customers, including existing local telephone companies, long-distance companies, internet service providers, competitive telecommunications companies, cellular operators and other telecommunications providers, to offer additional services to new and existing customers in the markets the Pathnet Group serves without having to expend their own resources to build, expand or upgrade their own networks.
- 9. As of February 28, 2001, the Pathnet Group employed approximately 255 employees. Immediately prior to the Petition Date, the Pathnet Group, in a cost-saving measure, terminated the employment of approximately 17% of its employees. As of the Petition Date, the Debtors employed approximately 207 employees.
- 10. As of December 31, 2000, the Pathnet Group reported approximately \$298 million in assets and approximately \$472 million in liabilities on a consolidated basis.
- 11. As of December 31, 2000, the Pathnet Group's network consisted of over 6,300 wireless route miles providing wholesale transport services and 1,400 miles of installed fiber, with collocations in 73 cities.

- 12. The Debtors were forced to file for Chapter 11 protection because, despite diligent efforts, they have been unable to obtain sufficient capital to fund operating shortfalls while the Pathnet Group's telecommunications network is being developed.
- 13. On or about April 19, 2001, the United States Trustee appointed an official committee of unsecured creditors in the above-captioned cases.
- 14. Pursuant to 28 U.S.C. § 1334, the Court has jurisdiction over this Motion, which is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2). Venue of the Debtors' Chapter 11 cases and this Motion is proper in this district under 28 U.S.C. §§ 1408 and 1409. The statutory predicate for the relief sought herein is 11 U.S.C. § 365(d)(4).

#### RELIEF REQUESTED

15. The Debtors respectfully request the entry of an order extending the time to assume or reject all of their unexpired leases of nonresidential real property by one hundred and twenty (120) days, through and including October 1, 2001.

#### BASIS FOR RELIEF

16. The Debtors are lessees under numerous unexpired leases of nonresidential real property located throughout the United States (collectively, the "Leases"). At present, the Debtors have identified approximately 342 Leases. These Leases consist of leases of office space, two warehouse leases, and numerous leases of space for the placement of telecommunications equipment.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> Nothing in this Motion constitutes an admission by the Debtors that any of the Leases constitute a true lease. The Debtors reserve their right to challenge the characterization of any of the Leases, and seek this extension of time to assume or reject the Leases out of an abundance of caution.

- 17. The Leases are listed on Exhibit A to this Motion.<sup>2</sup> The Leases are distributed among the Debtors as follows:
  - PTI is the lessee under 1 lease;
  - PNI is the lessee under 296 leases:
  - POI is the lessee under 23 leases:
  - POV is the lessee under 16 leases; and
  - PRE is the lessee under 3 leases.
- 18. Section 365(a) of the Bankruptcy Code permits a debtor in possession to "assume or reject any executory contract or unexpired lease of the debtor," subject to the court's approval. 11 U.S.C. § 365(a); In re Rickel Home Centers, Inc., 209 F.3d 291, 298 (3d Cir. 2000) ("Section 365 enables the trustee to maximize the value of the debtor's estate by assuming executory contracts and unexpired leases that benefit the estate and rejecting those that do not") (citations omitted). Each of the Leases is subject to assumption or rejection by the Debtors under § 365(a).
- 19. Section 365(d)(4), however, places time limitations on a debtor's ability to assume or reject an unexpired lease of nonresidential real property. This provision states, "if the trustee does not assume or reject an unexpired lease of nonresidential real property under which the debtor is the lessee within 60 days after the date of the order for relief, or within such additional time as the court, for cause, within such 60-day period, fixes, then such lease is deemed rejected . . ." 11 U.S.C. § 365(d)(4).

<sup>&</sup>lt;sup>2</sup> The list of leases on Exhibit A is not intended to be an exhaustive list of the Debtors' unexpired leases of nonresidential real property, but merely represents the leases identified by the Debtors as of the date of this Motion. By this Motion, the Debtors seek an order extending the time to assume or reject all of their unexpired leases of nonresidential real property. Nothing herein is intended to be a waiver, release, or impairment of any and all of the Debtors' rights, claims and defenses with respect to the Leases, and the Debtors intend to reserve and enforce their rights, claims, and defenses relating to the Leases to the full extent of the law.

- 20. The initial 60-day period in this case (the "Assumption/Rejection Period") will expire on or about June 1, 2001. This period will not provide the Debtors with an adequate amount of time to make the assumption or rejection determinations with respect to the Leases.
- 21. Courts consider a variety of factors in determining whether a debtor in possession has established cause for an extension, including the importance of the lease to the estate, whether the case is complex and involves large numbers of leases, and whether the debtor has had sufficient time to intelligently appraise its financial situation and the potential value of its assets to a plan of reorganization. See In re Service

  Merchandise Co., Inc., 256 B.R. 744, 748 (Bankr. M.D. Tenn. 2000); In re Wedtech Corp., 72 B.R. 464, 471-72 (Bankr. S.D.N.Y. 1987). In this case, each of these factors suggests that the Debtors have cause for an extension.
- 22. First, the Leases are especially important assets of the Debtors' estates. The Leases are essential to maintain Pathnet's telecommunications network and to facilitate a sale of the Debtors' business as a going concern. A going-concern sale is likely to maximize recoveries for all creditors.
- different debtors and have been procedurally consolidated. The Debtors' consolidated assets and liabilities, as of December 31, 2000, were approximately \$300 million and \$500 million, respectively. Since the Petition Date, the Debtors have been consumed with a vast number of exigent administrative and business decisions and have been unable to evaluate the large number of Leases identified to date. Without an extension of the Assumption/Rejection Period, the Debtors may lose valuable assets by the automatic

rejection of the Leases or incur burdensome administrative expenses by the premature assumption of the Leases.

- 24. Any decisions relating to the disposition of the Leases will largely depend on the interest expressed by potential buyers. These potential buyers, some of whom have not been identified, will need time to conduct due diligence and analyze the leases in the context of their particular needs. The Debtors intend to implement an intensive auction process designed to yield the best and highest value for the assets of the estate. Despite the diligent efforts of the Debtors and their advisers, it is simply too soon to conclusively determine which assets will be attractive to buyers and therefore have value to the estate.
- 25. Indeed, in determining whether a Debtor has established cause for an extension, "it is permissible for a bankruptcy court to consider a particular debtor's need for more time in order to analyze leases in light of the plan it is formulating." In re

  Channel Home Centers, Inc., 989 F.2d 682, 689 (3d Cir. 1993). The requested relief will provide the Debtors with the time and flexibility necessary to coordinate the assumption or rejection of their leases with the auction/sale process. The Debtors should not be forced inadvertently to reject a valuable lease or assume an undesirable lease. See In re Service

  Merchandise, 256 B.R. at 748 (granting extension in part because the debtors otherwise would be compelled to assume substantial liabilities or forfeit the benefits associated with the leases).
- 26. The lessors will not be prejudiced by the requested extension of time. The Debtors have moved expeditiously to initiate the auction process. In particular, the Debtors retained Houlihan Lokey Howard & Zukin ("Houlihan Lokey") as investment

bankers to assist in the sale of the Debtors' assets. Houlihan Lokey has already commenced marking efforts, including distribution of an extensive sales memorandum, contact with prospective buyers, and creation of an on-line due diligence room to facilitate the due diligence of prospective buyers. The Debtors currently anticipate conducting an auction in late June and filing a motion for approval of an asset sale in time to be heard by the Court in July 2001. In connection with this expedited schedule, the Debtors will move as quickly as possible to evaluate their leases and file a motion to assume or reject each lease as soon as an appropriate final determination is made.

- 27. For the foregoing reasons, the Debtors submit that sixty days is not a sufficient amount of time to afford them a reasonable opportunity to evaluate all of their leases and that cause exists for the requested extension.
- 28. The Debtors seek the relief requested herein without prejudice to their right to request further extensions of the time to assume or reject the Leases pursuant to § 365(d)(4) of the Bankruptcy Code.

#### NO PRIOR REQUEST

29. No previous application for the relief requested herein has been made to this or any other court.

WHEREFORE, the Debtors respectfully request that the Court enter an order extending the time to assume or reject the Leases by one hundred and twenty (120) days, through and including October 1, 2001, and granting such other relief as may be appropriate.


