("IDS") have reached a mutually-agreeable resolution of all of the unresolved issues in this arbitration. BellSouth and IDS, therefore, plan to file an executed copy of the Interconnection Agreement incorporating the terms and conditions of this resolution with the Florida Public Service Commission for approval within thirty days.
