
3. The City of Deltona has a small area in the southeast quadrant of the City which is served by the 407/321 area code. The remainder of the City and of Volusia County is served by the 386 area code. Substantial confusion exists within the City and within the County because of the division between the two area codes to the detriment of residents and commercial interests within the City and within the County. Unification of the entire City and County within the 386 area, while permitting existing customers to keep 407 area code numbers, would materially benefit the economic and social interests of the City, the County and its residents.

4. The Petitioner desires to see relief plans developed and adopted which provide for transfer of the 407/321 area code within the City of Deltona and Volusia County to the 386 area code for all new numbers.

WHEREFORE, City of Deltona petitions the Florida Public Service Commission to intervene as an official party of record in Docket number 010743-TL.


